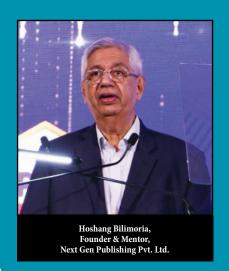

resilient auto component suppliers, along with the commitment of Original Equipment Manufacturers (OEMs) to long-term strategies, forms the bedrock. Technological advancements are being rapidly commercialised, driven by heightened customer awareness. A wide range of options, including swappable Battery Electric Vehicles (BEVs) in the HCV segment, provides consumers with various choices.

As the commercial vehicle industry moves toward a greener and more technologically advanced future, capacity expansion (including battery plants) and IoT 4.0 adoption are becoming more important in setting new quality benchmarks.

H1-FY26 brought a surge post September 22, 2025 with GST and the festive season reviving demand. It brought in optimism on the fronts of finance and infrastructure whilst construction activities slowed down due to prolonged monsoons. At 2,40,000 units, CVs grew by 8.3 per cent (YoY) in Q2-2024-25. M&HCVs benefited from strong freight demand and LCVs turned around with slight improvement due to intracity logistics. Exports grew 22 per cent in the same period. The outlook for the remainder of the fiscal is encouraging. Mark your calendars for the awards scheduled towards mid-March 2026 and the jury round earlier, promising a remarkable experience.

METHODOLOGY

THE EVALUATION PROCESS COMPRISES THE FOLLOWING STEPS:

- 1. All the prospective candidates or their sponsors will fill in the 'Nomination / Application Form'
- 2. All the applicants will be given a self-assessment form with the required guidelines. They will carry out a self-assessment and submit it to CV / Metric.
- 3. Metric will study and compile all the self-assessment forms.
- 4. Metric will visit the top 10 applicants in each category of applicants to understand the merits of the self-evaluation done by the applicants.
- 5. Top performers will then be decided based on their self-assessment and independent assessment carried out by Metric using the BQF model for Journey of Excellence.
